- \$900,000 for delay in corrective surgery following complications of a hysterectomy
- \$750,000 for delayed diagnosis of breast cancer
- \$500,000 for a delayed emergency room diagnosis of a heart condition
- \$450,000 for misdiagnosis of kidney cancer and delay in treatment
- \$450,000 for a nursing error resulting in overdosing of insulin in diabetic patient
